- Reminders:
 - LBGTQ+ Now at 530pm on every 4th Tuesday of the month
 - Mental Health for youth on the 4th Friday of the month at 5pm. (Looking for volunteers to do testimonials for social media campaign)
- STATS updates Most grants are on track with meeting most, if not all performance measures.
 - MAT Case Manager- 272 as of April (out of projected 180 for the year)
 - On Our Own- 2 grants, Hitting all of their PMs.
 - **TCA** started services again as of February 2021 and have steady referrals coming in.
 - **Family Navigation** has met/close to meeting all PMs for EOY goals.
 - COVID PPE all funds have been spent
 - Adolescent Clubhouse officially opening this month, have been offering virtual sessions since may.
 - Hub and Spoke- started operating in February; Still in implementation phase; advertising to local physicians to gain interest; Have enrolled 17 individuals to the hub as of April
 - SOR I NCE- Recovery Housing spent funding in March, so
 Oxford house is focusing all efforts on opening 3 new houses
 under SOR II Funding. Currently they have 2 houses under
 Contract in Chesapeake Beach, 1 for men and 1 for women.
 - **TCA-** Started back up in February and has had steady referrals since then.
 - **SOR II** All grants are struggling to meet PMs.
 - Crisis Services has had an increase in referrals and able to meet PMs
 - Health beginnings and MAT with Criminal Justice are behind, due to staffing issues and COVID-19 restrictions.
 - Have met with both vendors to discuss and provide technical assistance
 - -State Care Coordination is on task to meet PMs

- BUP- has Met a lot of PMs; Did not receive any requests for inductions and only 1 medication management request. PMs will be changing for FY22.
- **Supportive funds** We have not had many requests this year, referrals needed, we have a lot of funds left- We would need the applications by 6/15/2021.
- RRP- New process in place; Currently have 1 bed open for general and 1 open for intensive. Referrals have been sent and SMCN is working on filling them.
- **Bus Passes** Available for anyone in PBHS, contact Katie Wandishin
