The Local Behavioral Health Authority (LBHA) is pleased to announce the availability of gun locks for providers to distribute to clients. This initiative aims to enhance safety and support individuals during times of suicidal crisis.

Suicidal crises are often intense but temporary. Creating a physical and time-consuming barrier to accessing a highly lethal method like a firearm can allow the acute suicidal impulse to pass or provide an opportunity for intervention.



Opportunities and Recent Developments

CONSORTIUM NEEDS ASSESSMENT

The LBHA has been working on the Consortium Needs Assessment with the assistance of staff from Calvert County Public Schools (CCPS).

A portion of the needs assessment involved examining publicly available data sources such as MSDE, YRBSS, Student Discipline Data, and MDH data. Preliminary results show that Males and Black students are disproportionately suspended or arrested as compared to white students. However, there is a small percentage of black students (13.75%) as compared to white students (65.06%). Additionally, middle school students appear to need the most support, as the percentage of students experiencing bullying, sadness, and suicide warning signs is higher than high school students. We plan to post the full report once finished.
