On Our Own of Calvert & Homeless Service Board

Danielle Johnson and Corae Young worked together to provide a <u>presentation</u> on local resources available for the homeless population, including On Our Own of Calvert program, Continuum of Care (COC) Program, Safe Nights, our local Homeless Shelter, and more. ASO Transition Discussion

The new ASO transition from Optum to Carelon began on January 1, 2025. While we are still in the midst of this transition, we want to hear from local providers about any challenges they have come across. One issue is that LBHA's do not have access to the system yet so are not able to review any uninsured exceptions nor bed hold requests. There has been no insight as to what has happened to the requests from 12/31-current. One provider noted that there are multiple records for clients in the system. And finally, there was a discussion about calling provider support and not being able to get in touch with anyone. Providers that call will be placed on hold for hours and passed from one person to the next and never actually reach anyone. Carelon is working on hiring more staff to prevent this from continuing.
