LBHA Updates:

The LBHA staff provided <u>updates</u> within the department. Please see attachments if you are unable to access documents through the links.

Targeted Case Management at Cornerstone Presentation:

Jay Rhone presented on the <u>Targeted Case Management program offered at Cornerstone Southern Maryland</u> for individuals with behavioral health disorders. This program provides linkage to necessary services and supports. Cornerstone staff also presented on their other programs, including the Psychiatric Rehabilitation Program (PRP), Vocational

Services, Residential Rehabilitation Program (RRP), Residential Crisis Services (RCS), In-Home Intervention Program for Children (IHIP-C), Youth Psychiatric Rehabilitation Program (Youth PRP), Assertive Community Treatment (ACT).

Adolescent Club House Pathways Presentation:

Sarah Pryor gave a presentation on the <u>Pathways Adolescent Clubhouse (PAC)</u>, which provides recovery-oriented programming to youth aged 12-18 at risk for substance use. The program offers Botvin Life Skills, Narcotics Anonymous (NA), Alcoholics Anonymous (AA), homework assistance, and supported employment. The young adult peer support specialist (YAPRSS) works with the youth. Maryland Coalition of Families (MCF) also partners with Pathways to provide Family Peer Support to youth and their families.

Provider Updates:

Community Health (CCHD) shared that a mentoring program, Stella's Girls, is working on providing services to the Yardley Hills community. Smoking cessation and Saturday SAVES sessions are beginning soon, for more information, contact Jane Dodds (jane.dodds@maryland.gov).
