 - Update on Administrative Denials for SUD Providers (Effective 10/5/23)
 - LCPC's can bill Medicare as of 1/1/24 (see below). However, to bill
 Medicare, the individual must be registered with CMS. I just checked
 the forms on the CMS website, and they have not been updated to
 show a LCPC can apply.
 - Effective January 1, 2024, the legislation allows LPCs and LMFTs to bill Medicare directly for mental health diagnosis and treatment services in most settings, except inpatient hospital. The bill, passed into law in December 2022.
