#### 1st Q Updates

Danielle Reumont and Justin Thompson gave a <u>presentation</u> on the grants performance during the first quarter of FY25 and expectations for the remainder of the year. Danielle Johnson from On Our Own discussed the current challenge they are facing with a delay in moving into the new building and needing a temporary place to go. If anyone is aware of a space that might be available, please contact Danielle at <u>danielle.johnson@onourowncalvert.com</u>. They must be out of their current location by March. Danielle will be typing up a description of the type of space that is needed and sending it to the LBHA to disperse to the Advisory Council. Andrea also gave a presentation on 1<sup>st</sup> Quarter Strategic Plan updates. There is a concern regarding pulling lists from high utilization in Calvert Health due to folks that are diagnosed with both medical and behavioral health, not making the list due to the medical component. Noelle and Kara already have a list of high utilizers within Calvert Health and so we will include them in future planning meetings.

#### Presentation on Calvert Health Needs Assessment Final Results

Kara gave a presentation on the results from the Calvert Health Needs Assessment and discussed future plans to address the results.

#### **PBHS Utilization Data Presentation**

Andrea gave a <u>presentation</u> on the Public Behavioral Health System utilization from FY2023 and FY2024 for Calvert County residents in Calvert County Behavioral Health services. Andrea reviewed each slide to show the differences in utilization between ages and expenditures spent for each year. This information will be going into the next Strategic Plan and will need to be analyzed for future goals.
